**RELIGION & CROSSDRESSING: INSIGHTS FROM KATHY HELMS**

Last fall, Tri-Ess Alpha Chapter President Kathy Helms spoke on the relationship between Religion and Transgenderism. As she pointed out, "This is significant because an awful lot of folks in the gender community are religious". Moreover, some on the fringe element of the Christian Right are seen as attacking the transgender community. As the focus of religious ire, we are forced to deal with these issues.

Kathy noted one tragic recent event, cited by IFGE's Merissa Sherrill Lynn at the Spring '95 Atlanta Action leadership convention. As it happened, two of the representatives there were coincidentally members of the Christian Coalition and Focus On The Family. They themselves were made the focus of resentment by other gender community members, who vented their frustration on them for past attacks from the Religious Right. This was, Kathy said, the equivalent of drawing a circle around these people and casting stones. What kind of community are we if we vilify and scapegoat our own members?

Warming to the topic itself, Kathy explained that religions are a way people make sense out of life. They tend to fall into the category of either MONAST or TRANSCEDENT.

Monast religions see everything as a continuum and interrelated, and aren't surprised at transgendered behavior. Hinduism teaches about reincarnation, so crossdressers may have been female in a previous life. Or Native American Shamanism teaches of the Berdache and Two-Spirit people, an affirmation of the feminine spirit.

Transcendent religions by contrast see things in terms of polarity: Good Vs Evil, Black vs. White, or in our case, Male vs. Female. Christianity, Judaism, and Islam are all transcendent religions. To these duality-minded religions, confusion of the sexes is seen as unnatural.

The centerpiece of this argument is the Old Testament verse Deuteronomy 22:5. It says that men shall not wear what pertains to women-any who do so are detestable in the sight of God. On the surface, this is a pretty damning passage. When we hear someone quote this at us, it's the ultimate rejection; "It's as if your own religion tells you you're trash," as Kathy puts it.

But what does this verse actually mean? Many people who quote it have not done serious biblical study around it. Scholarly research reveals that the actual purpose, the "Framer's Intent", was a reaction by the Nation of Israel to pagan polytheistic practices of their neighbors.

Other religions of that time had both Gods and Goddesses. At certain Goddess' temples, some of the male priests would crossdress and offer themselves sexually to congregants as a representation of the Goddess herself. "It was this cultic temple prostitution which was being prohibited," Kathy notes, and not the broader issue of social crossdressing. On that subject, the Old Testament is silent. Any blanket condemnation of transgender behavior stemming from this would be the commentator's own biased interpretation, not the scripture itself.

When asked about the proper response to gender-baiting, Kathy counsels "Don't demonize people who would disagree with you-refuse to respond in kind". She also recognizes that there are some people so full of anger that they cannot be

## President's Message

Have you heard the joke about the bank clerk who called a customer claiming their checking account is overdrawn? When confronted, the customer exclaimed, "I must have money in my account. I still have checks!". Well, folks, I'm down to my last check AND our club's checking account is down to \$300. True, IFGE owes us some money for expenses accrued for the *Cal Unity* convention. But let's face it, one can't get water out of a rock. Until we get reimbursed we'll be making a few adjustments.

Additionally, few things have changed with Powder Puffs since last year. Most obvious is our new meeting room. Not only is the new management more friendly to work with, but we have the added bonus of greater security — very important for us. Many of you remember that two couples were robbed at gun point at the Pioneer Best Western while walking to our meeting room. Well it seems the violence has escalated (see *Don't Look Back*, Page 1). Fortunately, the Placentia Holiday Inn is set back from the freeway, and (hopefully) not such an easy target.

But this added security is not without cost. Our meeting room is more expensive. Also, it is more difficult for me to find food vendors. Those I have located a bit more costly. As of this writing, our meeting expenses are running about \$370 per month. Other expenses, like newsletter & phone, are around \$170 per month.

So in light of all of the above and other factors such as lower attendance over the last several meetings, the Board (with an eye towards balancing the budget) voted to take more prudent fiscal measures. Thus, the meeting fee will be changed to \$15 per TG person. Of course, we will maintain the "Ladies Free" policy. Always have. Always will.

Additionally, starting this month we'll eliminate the changing room in order to help keep costs down. Spending \$65 for only one or two people is difficult to justify. However, we'll try and bring it back for the October Vendor Night meeting.

Speaking of October (nice segue, No?). The Holiday Inn needed to rent the meeting room for three consecutive days which conflicted with our meeting night. As a show of good faith, they offered us the room on another night for FREE! We choose the night of October 4th, because of less interference with the other groups in the area. So **NOTE: October's Vendors Night is the First Saturday, October 4th.**

Also, the Board voted to adjust the yearly membership dues to \$36 per year. At present, we have 45 registered members. This change, along with the others; will help cover some of the monthly expenses. This averages to a nice, round \$3 per month per membership. Membership runs from October 1st through September 30th. Still rather inexpensive, but necessary.

At the July meeting, only 16 voted for some very important issues. After getting the final vote total from Price-Waterhouse, I can proudly announce a new member to your Board, **Jeri Thompson**. Not surprisingly, Jeri has already rolled up her blouse sleeves and is digging right in. Along with Diane, she has agreed to help plan some new social events. The dynamic duo of Jeri & Diane will also be getting new brochures printed and distributed to some of our local vendors and social spots. After the first of the year, look for some fun outings from these two. Thanks Girls!

I'd also like to thank Loren Wingert for serving on the Board. She was very helpful in volunteering for some duties during the last convention even though it is her busy time of the year. As she transitions I wish her the best of health and luck. Go Girl!

Another hot ballot issue confronted in this year's election was the question of becoming a Renaissance Chapter. The membership voted this down, mainly due to the fact that REA is re-organizing their newsletter and other issues. When things get settled for them, we'll look again at joining them as a Full Chapter. In the meantime, we'll remain an Affiliated Group.

Also, on the ballot was a question asking, "What do you expect from PPOC in the future?". The biggest response was the to have more social evenings. As mentioned earlier, Diane and Jeri are working on something after the first of the year. We will be having our Ten-Year Bash next month at the magnificent Crystal Room in the Burbank Holiday Inn and the Halloween Monster-Mash in October at the Fullerton Holiday Inn. After the first of the year, we'll plan some more fun things to do about 3 or 4 times a year.

Other responses included better food and speakers. I'll take the blame on this one. Since moving the meeting to Placentia, I've yet to find as many places which will deliver there as we had at the Best Western. But I'm still working on that one. When it comes to new speakers ideas, well, I'm running on empty. Any suggestion? Call, write or e-mail (PPOC@aol.com) No need to panic though, we do have the next couple of months planned. The Board will be helping me in this matter also. So look for improved meetings in the future.

## Editorial

### MY FINAL COMMENTARY

I have had a month since the demise of *Cross Connection* to think about what I wanted to say as my final words to all of you. Given that this year saw the demise first of *Cross-Talk* and then the BBS, my original thoughts were to blast some connected angry thoughts. However, even as I prepare to bow out from the transgender community entirely, I feel a responsibility to try, one last time, to impart truth that you may not want to hear, but need to. (After all, that's what I used to do every month in the magazine.)

My honest opinion is that my use of the term "transgender community" is less than accurate, because what I have seen and experienced does not qualify as a "community". A community has a mutual support infrastructure, and lately an attitude of selfishness has had the effect of destroying the infrastructure I -- and many others like myself -- worked very hard to create for you.

This is not going to be a case of sour grapes, because the loss of the two resources I was operating is not the only loss you are facing as a result of your inability to provide financial support to those who have tried to be of service to you. IFGE is on the verge of defaulting on the lease for their headquarters, on the heels of being left with a substantial uncollectable balance with a magazine distributor who filed Chapter 11 early this year. Renaissance recently sent a letter to its members indicating that they no longer have the funds to publish their newsletter, and they are probably likely to have to give up their office space next. AEGIS has been given an ultimatum of sorts by Dallas Denny to become financially viable by the end of the year or risk losing the ability to continue publishing "Chrysalis" and provide resource information. ICTLEP is waiting for someone to deliver the eulogy after Phyllis Randolph Frye professed her exhaustion and no one has been able to adequately fill her shoes. Tri-Ess operates on a virtual shoestring and I find myself wondering how much longer they can continue.

What I do not believe any of you realize is that the loss of these support mechanisms seriously jeopardizes your freedom to express transgender identity. We live in an era where lawmakers, dependent upon the Christian conservative organizations to fund their re-election campaigns, will attempt to legislate anything "immoral" out of existence. How long will it be before we, the

transgendered, become their target? And if all the organizations and leaders who spoke up for you have been run out of existence because you didn't give them the support they needed to continue helping you, who is going to fight your battle for your freedom?

No one, that's who.

We may well find ourselves thrust 40 years into our past, where crossdressing took place completely in secret, with clandestine organizations ... where raids will result in drag queens being hauled away en masse ... where sex reassignment surgery will only be legal in a handful of countries, and you may not be able to return to your country of origin afterwards ... where there will be no weekend events where you can express yourself full time for a few days.

Sound farfetched? I suggest you think about it while you count the money you've saved for that new dress, or wig, or prosthesis, or whatever ... money that you *could* have given to IFGE, Renaissance, AEGIS, ICTLEP ... even for a subscription to *Cross-Talk* or *Cross Connection*.

I can tell you where I will be when those dark days come to pass. I will be somewhere, living my life, presenting an image to the world that is so conformingly "normal" that no one will realize the new restrictions should apply to me. Having spent the last ten years trying to be of service to this so-called "community", I am now going to look out for my own interests and self-preservation. In other words, I am getting on with my life and leaving all of you behind like a bad dream.

I realize that many of you are going to want to reply in anger to this final missive of mine. Save your time and energy: By the time you see this I will have shut down the Internet server at *Cross Connection* permanently, so I'll never see your response. And that's the way I prefer to make my exit ... unreachable and deliberately detached.

So, at least for me, the battle is over. For the rest of you, it is likely just beginning. Good luck to you all. You'll need it.
