SPECIAL GUEST AT CHI'S SEPTEMBER MEETING

For our meeting last month we had a special guest, Ms. Ralla Klepak, who is a practicing attorney in the City of Chicago. Ralla is a friend of Sharon H., who arranged for the visit, and we only regret that we did not have enough notice of her being with us to give advance publicity for her visit in our newsletter last month. Ralla spoke to us on our most pressing concern: "What are the Laws in the City of Chicago regarding Cross-dressing?" The simple answer she gave was, "None!" She went on to explain, however, that although there are no longer any valid laws on that subject on the books, any thick-headed/insensitive Policeman can make life miserable for us if he chooses by citing the catch-all law of "Disorderly Conduct." The bottom line still is, "They can't legally stop you from cross-dressing, but they can darn sure make you wish you hadn't!" Ralla has handled a number of cases concerning "our" type of people, and gave us several first-hand examples of both good and bad Police Officers from her personal experiences. We were very glad to have Ralla with us, and hope that she will visit us again when we can give adequate advance publicity, and have even more people present to hear her.

After Ralla's talk, and the following general discussion, we proceeded into our regular Chapter meeting. Deanna, our President, had a special word of welcome for our many new members, and by way of introduction had everyone stand one-by-one so both old and new members would be sure who each person was. Deanna re-capped our summer activities: In June, we had our regular meeting in our "old stand-by" motel; In July, we had a special outing at the Lite Factory Disco Lounge in Chicago, which was certainly different from our customary monthly meetings; In August, there was no formal meeting, but there was a small dinner-theater party for couples only, as well as a weekend outing sponsored by Outreach; and then September, with our monthly meeting in Linda and Gerry's home, with a very large attendance.

Deanna then brought up the subject of future visits to the Lite Factory Disco Lounge, since a number of members had questions and concerns about returning there. The consensus was that the Lite Factory is not a "bad" place, but that any visits by our members should be on a strictly individual basis.

A question was raised about the purpose and use of our Chapter Reserve Fund. Deanna, and others, explained that this fund was established in the spring of 1976 primarily as a cushion against the time the Chapter was short of cash for motel rental, refreshments, etc. It was also intended that this fund could serve as assistance for any member who had a legal problem concerning cross-dressing, and was willing to pursue it in the Courts. A suggestion was made that the use of this fund be expanded into other areas. After a discussion of the pros and cons of this suggestion, it was decided to table the matter until our October meeting when it would be brought up again.

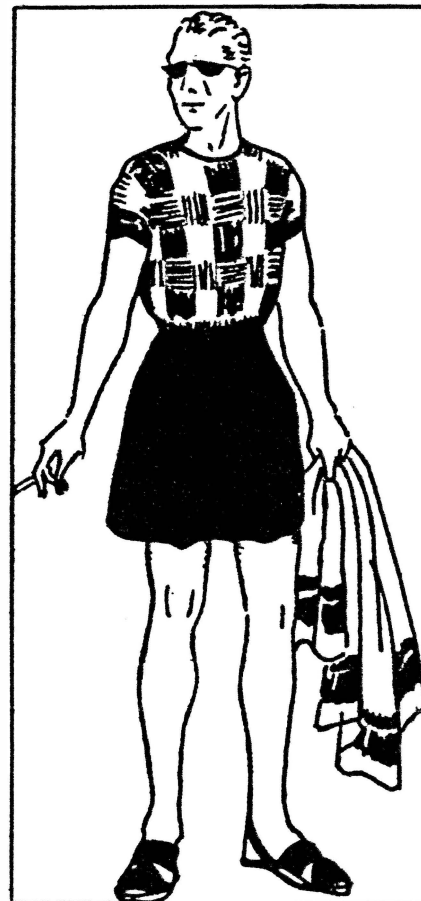

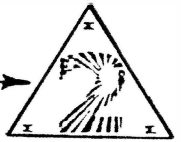
Not only is it a hot nuisance, but it also constitutes discrimination, since the female employees are allowed to show up for work in nice cool outfits.

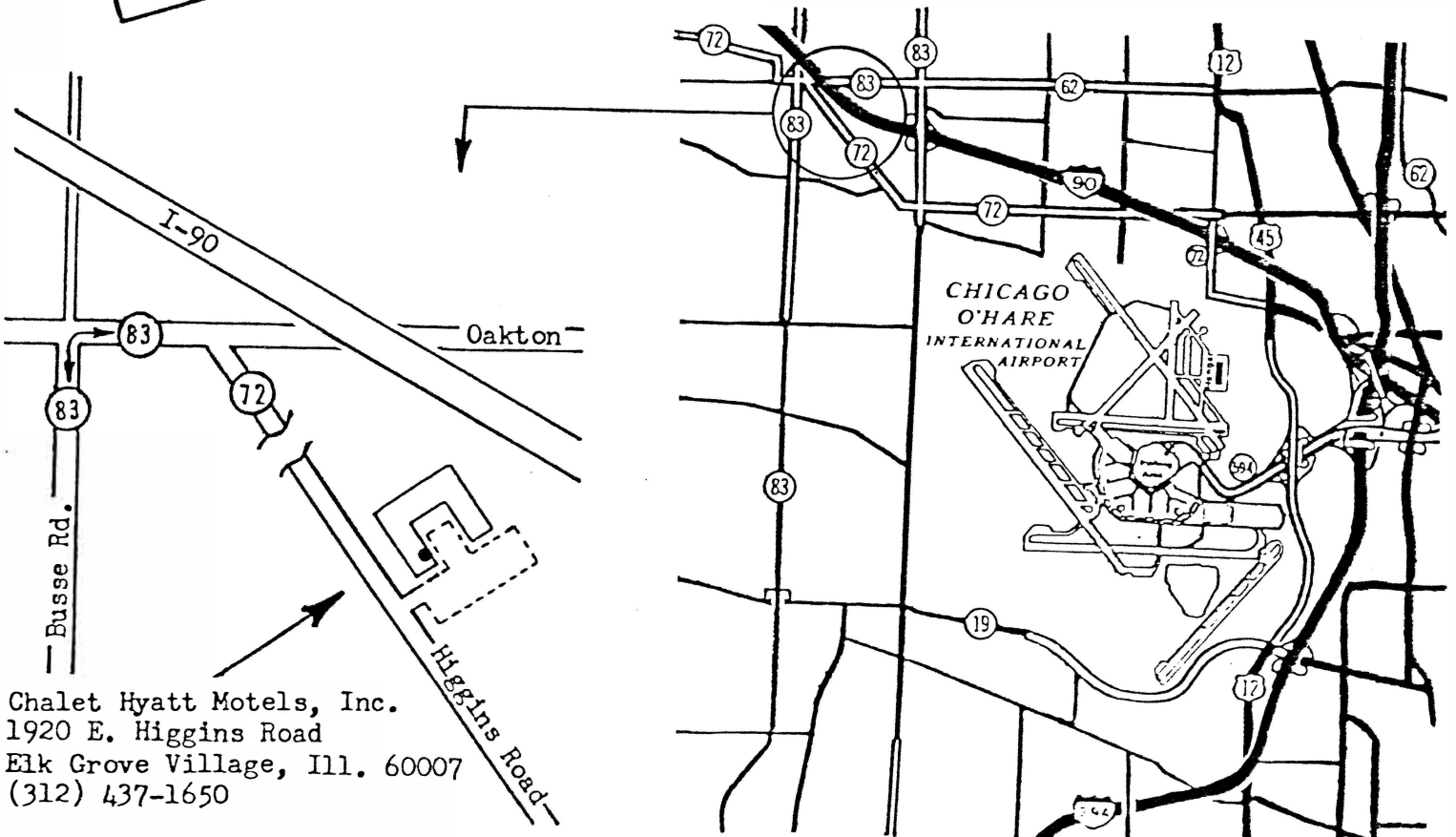
