## Cases Close: First sentences handed down under law boosting penalties for crimes against transgendered

Settlements have been reached in the first two criminal cases brought under a new state law that enhances penalties for hate crimes against transgendered persons.

On Oct. 26, Hector Bautista, 19 pleaded guilty to attempted murder and admitted to a July 18 hate attack against Mario Gonzalez, a.k.a, "Mari Mar," a transgendered woman associated with Bienestar's Transgenderos Unidas.

Bautista confessed to using a baseball bat against Mari Mar with the intent of causing great bodily injury. Bautista was sentenced to seven years in prison, which was considered a stiff sentence even with the hate crimes penalty enhancement because he has no prior record and the victim was not seriously impaired by the attack.

Bautista's brother Antonio and his cousin Javier Bautista also plead guilty to assault with a deadly weapon and the commission of a hate crime against a transgendered person. But because neither had a prior criminal record and Javier could not be directly linked to Mari Mar's beating and Antonio stayed in the car during the attack, their sentences were considerably lighter.

Javier Bautista was given a suspended five-year prison sentence, based on the conditions that he spend a year in Los Angeles County jail, take anger management classes for a year, attend a hate crimes program at the Simon Weisenthal Museum of Tolerance, and make restitution.

Antonio Bautista received four years in prison, suspended on similar conditions, except that his is required to serve only a six-month jail sentence. If either man violates the conditions of their sentences, the settlement agreement is revoked and they will be sent to prison to serve their full sentence.

In the case of the July attack against Angie Briones, a 17-year-old juvenile pleaded guilty on Oct. 25 to assault and the commission of a hate crime against a transgendered person. Briones was attacked outside the Jeff Griffith Center. The youth will spend up to a year in a secured "camp" for juvenile offenders.

He was also order to attend 150 hours of community service, mandatory counseling, and make restitution to both Briones and the Center (for throwing a brick through its window.)

She asked to see my driver's license to verify the number on it, etc. Because I am a senior citizen, the fee was only three dollars. From there, I was sent to the area to be photographed. The woman who was operating the cameras was busy talking to somebody and when she noticed me standing there she apologized for the delay. She looked at the computer screen and said "Robert."

I said, "Yes . . ."

Then she looked at me quizzically and asked, "Are you Robert?"

I answered, "Yes" and she proceeded to take my photograph.

After she finished taking a photograph she said, "You look pretty good, Robert" and then handed me a form for my signature. As I was leaving she said in a

## Artificially grown sex organs may soon be possible

WASHINGTON (Reuters) - Because of recent breakthroughs in genetic research it may be possible within 25 years to artificially grow penises and vaginas that can be implanted as functioning organs in humans, the Impotence World Association said Friday. With more than 80 million men and women in the United States suffering from some form of impotence, doctors say sexual healing, especially for women, is just around the corner with new developments in genetic research and Viagra-like drugs. Dr. Myron Murdock, national director of the impotence group, said in the near-future scientists will be able to construct male or female genitalia from human cells by culturing and growing them over an appropriately shaped lattice or mold.

In the process of these cells growing, differentiation into the various layers of the vagina and penis will occur. "As unbelievable as this may be, the process of tissue engineering, and the ex vivo (outside the body) production of functioning human organs such as the penis and vagina are being done today in the laboratory," he said. Male and female genital organs which are missing, nonfunctional, or inadequate may be replaced by the artificially grown organs which would be "surgically implanted to produce a functioning, erogenous sexual organ," he said.

New "miracle drugs" for impotence will also soon be available for men and women, Murdock said. In 1998, Viagra became the first FDA-approved oral drug treatment for male erectile dysfunction. Since then a barrage of new drugs and treatments have sought U.S. Food and Drug Administration approval including TAP Pharmaceutical's apomorphine drug called Uprima, which stimulates pelvic congestion -- erection in men and arousal in women. Also in development are new and more specific versions of Viagra -- known to scientists as type-5 phosphodiesterase inhibitors. They will cause fewer side effects such as facial flushing, headaches, indigestion and vision disturbances, Murdock said. "Some of these newer, more specific Viagra-like drugs will work faster, and may last up to 24 hours, making sexual relations more spontaneous," said Murdock, a urologist and clinician and surgeon.

In the next few years, sexual dysfunction treatments specifically for women, who suffer in greater numbers than men, will be widely available,

Murdock adds. For example, Viagra could be licensed for use by women in three to four years, its manufacturer, Pfizer Inc., said in October. "(Viagra) may be the start of providing medication for women," Murdock said.

## Lesbian Group Found Guilty of Sex Bias

VANCOUVER, B.C. -- A lesbian organization in Canada has been ordered by a British Columbia Human Rights Tribunal to pay more than \$2,000 in damages after being found guilty of violating provincial discrimination law in banning a transgendered person from its drop-in center.

The Vancouver Lesbian Connection has been ordered to pay Susan Mamela, a preoperative male to female transsexual undergoing hormonal therapy, \$2,030 in compensation for dismissing her because of her masculinized appearance and manner.

Mamela described herself to the tribunal as a radical lesbian feminist who rejects patriarchal socialization and its attempt to redefine her into rigid stereotypical roles. "I refuse," she said, referring to members of the lesbian group, "to let them make a woman out of me."

"My client's view is that she's not a woman and never can be a woman because it's a social-political construct based on a lot of stereotypes and restrictions," Mamela's lawyer, Clea Parfitt, told members of the rights tribunal. "She prefers the term female."

Mamela approached the lesbian group in February 1996 and asked to become a member. She was told she couldn't join because she was born male. The following May, the group changed its membership policy to include transgendered and bisexual women and Mamela joined.

But problems developed. The group felt it inappropriate that Mamela should answer phones to the women's crisis line because she sounded like a man. More generally, Mamela offended other group participants for being "aggressive and mannish." She was asked to leave the group less than a year later after the group engaged in a heated argument over what constituted womanhood.

The tribunal found such action in violation of provincial human rights laws and awarded the cash settlement for injury done to Mamela's "dignity, feelings and self respect."

## Texas Appeals Court says XY vagina is male

*Texas Appeals Court says XY vagina is male! Maybe it is time for some "male" toplessness and some transsexual employment lawsuits with the EEOC since transsexuals cannot change legal sex.*

The case known as Littleton V. Prang has been decided and it is horrible news for transsexuals in Texas. In the abbreviated version, here is what the court has ruled:

1) "Medical science recognizes that there are individuals whose sexual self-identity is in conflict with their biological and anatomical sex. Such people are termed transsexuals."

2) "A transsexual is not a homosexual in the traditional sense of the word, in that transsexuals believe and feel they are members of the opposite sex. Nor is a transsexual a transvestite. Transsexuals do not

believe they are dressing the opposite sex's clothes. They believe they are dressing in their own sex's clothes."

3) "Christie Littleton is a transsexual."

4) "Through surgery and hormones, a transsexual male (note the language of the court) can be made to look like a woman, including female genitalia and breasts. Transsexual medical treatment, however, does not create in internal sexual organs of a woman (except for the vaginal canal). There is no womb, cervix, or ovaries in the post-operative transsexual female."

5) "The male chromosomes do not change with either hormonal treatment or sex reassignment surgery. Biologically a post-operative female transsexual is still a male."

6) "The evidence fully supports that Christie Littleton, born male, wants and believes herself to be a woman. She has made every conceivable effort to make herself a female, including a surgery that would make most males pale and perspire to contemplate."

7) "Some physicians would consider Christie a female, other female physicians would consider her still a male. Her female anatomy is all man made. The body that Christie inhabits is a male body in all aspects other than what the physicians have supplied."

The court then makes the most offensive statement any transsexual could possibly imagine. "There are some things we cannot will into being. They just are."

"We hold, as a matter of law, that Christie Littleton is a male. Christie cannot be married to another male. Her marriage to Jonathon was invalid, and she cannot bring a cause of action

as a surviving spouse."

Last month TGAIN sent an Amicus or "friend of the court" brief which accepted by the court. Anticipating exactly this kind of ruling our brief asked the court to include in its decision a statement suggesting that the Texas legislature needed to pass a law (or perhaps laws) to clarify the issues involved in this case. On page eight of the court decision, the second paragraph reads:

"In our system of government it is for the legislature, should it choose to do so, to determine what guidelines should govern the recognition of marriages involving transsexuals. The need for legislative guidelines is particularly important in this case, where the claim being asserted is statutorily based. The statute defines who may bring a cause of action: a surviving spouse, and if the legislature intends to recognize transsexuals as surviving spouses, the statute needs to address the guidelines by which such recognition is recognized. When or whether the legislature will choose to address this issue is not within the judiciary's control."

The fact is that TGAIN has made three attempts to get exactly this kind of clarification entered into the Texas legislature. This past session we were told there was no need to have such clarification. As a result the bill died in committee. The Littleton case was exactly what TGAIN was working to avoid. Ironically, this ruling may be exactly what we need to get our legislation passed. The problem, and the blessing in disguise, is that the legislature does not meet this year. This gives us time to devise our strategy, lay the groundwork with legislators across the state, and put on a fullcourt press in the next session.

My point is that yes, this decision is terrible. The ramifications on issues like health insurance, employability, and of course our legal status as men or women, and only now beginning to become clear. Anyone who believe gays and lesbians had nothing in common with transgenders need only to see the court's use of DOMA against us. However, there is hope and that involves all of us in Texas. The time for hiding is over. This court ruling reaches into every closet. There is no hiding place in Texas. Tell your friends about TGAIN. Tell your family. Tell the friends of your family. Tell everyone you know in El Paso, Lubbock, Laredo, Corpus Christi, Austin, Houston, Dallas, Fort Worth, and anywhere else in this huge state. Talk to your friends in PFLAG, the NGLTF, the LGRL, and other transgender organizations. Tell them that TGAIN is committed to bringing the message to the state legislature that our biology is not our destiny. We are not our chromosomes. We have lost a major battle, but the war is only getting started. We will fight back.

A word of caution is in order. TGAIN does not believe in "outing." We do believe, however, that hiding as an excuse to do nothing is no longer acceptable. Never threaten another person with "outing." Talk with your friends. Reason with them, but never "out" someone against their will.
