So I stopped taking it but is has not gone S Regard totally away.And in fact Inoticed some new red raised hives like bumps, this morning. So I called him again and arranged an appointment a 15 C for 5P.M . He could not t figure it out. So tomorrow his secretary will try to get an appointment with a dermatoligist. That new doc 7. 7. T. 1 may have to do some sort of culture or biopsy to make a diagnosis. 181 1. 1. But This itching sensation is not very pleasant.

I also had a mild diarreha which I finally went to the lab

and gave them a stool culture. That turned out to be Giardia, the intestinal parasite with eight flagella which disrupts yhe digestion of fats. He started me om some pills to kill them. My bowl movements have improved already. And I'm feeling higher energy levels.

This gorgeous weekend was just perfect weather. So I did not go to Great America amusment park. Instead I rented a gas powered auger and dug the holes for Judge Kessler's fence, Luther's too as well as my fromt railing which got broken off. I'm going to replace it with a 4"X4" post instead of 2X4 I had.

Then Sunday Moses and I put up the actual pyywood privace panels. We got it all up and in place by mid afternoon so I Left him go and I worked on alone on the little easy one man stuff.

Doing all that work has left Little time for anything else. I've gotten off 5 pounds with all this work. I hope to drop another five yet this fall. (Fat chance with this appitite!)

"It is now 11:30 P.M. and I'm going to bed and get some sleep.

I gave my tenent a 30 day notice to vacate by October Ist. She left a note under my domr last week asking for an extension because she had not found another place. I responded that since she had 8 7.93 not paid her September rent as of then, I was not going to grant start out and extension. But If that was paid in full then, and if October 12-12-1 rent was also paid in full on the 1st of October, I would at least be able to concider an extension. Last evening I find another note under my door saying that she still had not found a suitble pl ace. She thinks that she can get a nicer and bigger place than she has here for less money. She will not. But her moniply late payments 1.8 . 4 . 1.31 of her rent has gone on for over a year and I've had enought of her bellyaching around.
