USPS Sex Policy May Cover TGs

On November twentieth 1995 ICTLEP received a fax of "NAPS" Vol 47 #16 with an article, a portion of which reads as follows:

The US Postal Service has completed a new policy that prohibits discrimination in the postal workplace based on sexual orientation or identity. Postmaster General Marvin Runyon issued the following statement about the policy: "The Postal Service is committed to ensuring a workplace that is free of discrimination and to fostering a climate in which all employees may participate, contribute and grow to their fullest. We recognize and value our diverse workforce and are committed to fair treatment of all employees.

"Harassment and disparate treatment based on actual or perceived sexual orientation or identity will not be permitted or condoned in the Postal Service. This policy does not alter current standards of conduct and dress for postal employees. All Postal Service employees have the responsibility to support this policy and to take appropriate steps to ensure a workplace free of discrimination against any person based on his or her sexual orientation or

identity." [emphasis ours]

Upon receiving the fax, ICTLEP Executive Director, Phyllis Randolph Frye, offered the following observations: "I believe that the 'or identity' language along with the 'or perceived' language was probably designed to cover the transgender community. I believe this even more because of the care that was taken to mention that dress standards were not altered.

"While ICTLEP cannot take credit for this policy, we do hope to honor the person or persons who did. ICTLEP began to educate the community in 1991 about the dismal state of transgender law, to design strategies for progressive change, and to provide tools for transgendered people to work on their own for legal change. In 1991, there was a lot going on in the transgender community, but there was a vacuum with respect to transgender law.

"Employment Policy has been in the ICTLEP name and focus since it began. While we're not the only organization in the the movement for transgender employment protection, ICTLEP has been and remains one of the leaders in the struggle."

Another Boston Transsexual Murdered

Following the May 15 strangulation-stabbing of Deborah Forte in Haverill, Mass., another Boston-area transsexual, Chanel Pickett, 23, was strangled to death in nearby Watertown, Mass., early on the morning of November 20, 1995. Arrested in the case was William C. Palmer, 34, a manager of computer programming for Unisys in Somerville. Pickett was found dead in Palmer's room around 1:00 PM, about eight hours after the murder occurred. Palmer's attorney called the police.

Palmer is reputed to be an admirer of pre-op transsexuals who frequented the Playland, one of Boston's two transsexual pick-up bars. On the evening of November 19, Palmer drove Pickett and her twin transsexual sister Gabrielle to their Chelsea apartment, staying for about 90 minutes to drink, and do cocaine he had purchased near the Playland. Palmer apparently attempted to persuade the twins to participate in a three-way tryst. Only

Chanel packed an bag and went home with him. According to Gabrielle, Chanel did not regard Palmer as a trick, but as a potential relationship partner.

Palmer's roommates stated he and Pickett spent five hours in Palmer's room, during which time an argument broke out. The roommates knocked on the door, but were assured everything was all right. Shortly thereafter, the conflict escalated and Pickett was strangled to death.

Despite admitting his guilt, Palmer entered a "Not Guilty" plea in Waltham District Court, basing his defense on grounds he was unaware Pickett was "a he," and that this discovery led directly to her strangulation. Buttressing Palmer's claim of ignorance, defense attorney Walter B. Prince, quoted in the *Boston Globe*, branded allegations "absurd" that Palmer dated transsexuals or knew Pickett had male genitals. He said, "We have it on pretty solid ground that any accusations of that nature are certainly false

and out of character for a gentleman who has lived the normal upstanding life that he has. He has worked every day of his life since high school and has deep roots in the community." Prince was further quoted in the *Boston Herald* as stating, "clearly [there] was a horrendous fight that occurred, and my client [Palmer] received multiple bruises and bites from this assailant." Prince did not address whether the bruises Palmer suffered might have been incurred while the victim struggled for her life.

Palmer's assertion of ignorance was refuted by patrons of the Playland in the strongest possible terms, including Gabrielle Pickett, the dead girl's sister. Typical of comments were those of one transvestite patron, who declared, "[Palmer] had approached me one time. He asked me if I had real

breasts. I said, 'No, because I'm not a pre-op.' That's when he seemed to lose interest." Another patron, 30-year old transsexual Toyaer Shearrion, who dated Palmer four times, stated, "He knew what he was doing. He loves them [transsexuals]."

Prosecuting Assistant District Attorney Thomas O'Reilly reputedly accepted Palmer's plea of initial ignorance of Pickett's gender. However, according to newspaper accounts at the bail hearing, O'Reilly quoted Palmer as declaring to the dead woman, just hours before he strangled her, "You're the best-looking pre-op transsexual I've ever seen."

In the words of Toyaer Shearrion, Chanel was "a beautiful person. She was always there for you if you needed something." As with Brandon Teena and Deborah Forte, the Transsexual Menace and friends will hold a Memorial Vigil on the opening day of the murder trial.

Editorial Comments by Ms. Nangeroni

Chanel Pickett had been fired by NYNEX last February, after defending herself against a co-worker's harassment. Currently, there is no legal recourse for transsexual persons who are fired from their jobs for reason of their gender, and honest transgender folks are rarely hired. Chanel turned to sex work to save money for surgery and medical needs. It is fair to ask if Chanel would be alive today had NYNEX supported her instead of joining with the worker who harassed her and firing her. The Employment Non-Discrimination Act (ENDA) will, if amended as planned, provide legal recourse in these situations, securing for transgender folks the right to work without harassment for their gender. Unfortunately, ENDA is not yet law.



Labels: Who Needs 'Em?

After reading Rachel Rudnick's rather interesting piece on gender terminology, I felt compelled to add my five cents (factoring inflation) because it amazes me how so many terms for transgendered people have cropped up over the last several years, like roaches crawling out of the woodwork. Jeez Louise! This community has more labels for it's members than items on a Chinese take-out menu!

So, I come to you with this question regarding terminology, please forgive me if I sound Forrest-Gump-stupid when I ask this, but—Why?

When I started wearing women's clothing at the tender age of 14, I had no label to attach to what I was doing. It was ten long, frustrating years before I finally stumbled onto an issue of *Penthouse Forum* which featured the magic word right on the cover—CROSSDRESSING! Seeing this, I said to myself: "So that's what it's called!" Later on, I learned the other word, transvestite, which I didn't par-

ticularly care for then and don't now.

In the good ol' days, I was content with just those two terms, thinking that was all there was. Then I entered the wide, wonderful world of the transgendered community and things suddenly became somewhat confused. All of a sudden, I learned there were heterosexual crossdressers (or transvestites), homosexual crossdressers (or transvestites), transsexuals, drag queens, female impersonators, androgynes, transgendered, bi-gendered, cross-gendered, etc., etc., etc. More labels than you can shake a WonderBra at!

Okay, okay! Before someone gets their panties in a bunch, I know full well that our community is incredibly multi-faceted, made up of all sorts of different people, each laying claim to a specific term, and, in some cases, protecting it with ferocious fervor, but where does the labeling end?

When I came out of the closet in 1991, I was already safe and secure in the knowledge of who and what I was, without the benefit of therapy, which

might be viewed by some as a minor miracle. (It didn't hurt that I didn't suffer from gender dysphoria.)

But what about today's newcomers? To enter this community and be bargaged by all these terms, not to mention the lack of knowledge regarding the division of sex and gender certainly won't help ease a newcomer's bewilderment over her own identity. In my position as a local outreach representative, I try to de-emphasize the importance of labels, especially to someone who might be unsure as to what they are in the first place. I think it's crucial for a person to decide on their own just who and what they are, minus outside influences.

As for me, whenever anyone asks what I am, I look them straight in the eye and tell them I'm a Democrat. That's a hell of a lot simpler than "African-American, Heterosexual, Retired Military Crossdresser." Beyond that, the only other label I'll answer to, the one label that should count the most in the hearts and minds of all of us, is this one... Human Being. Nothing more, nothing less. Think about it, people.

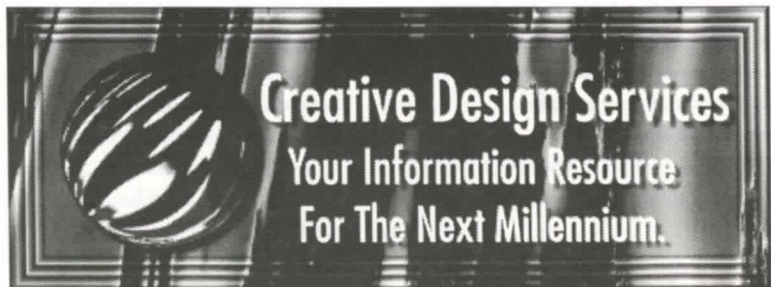

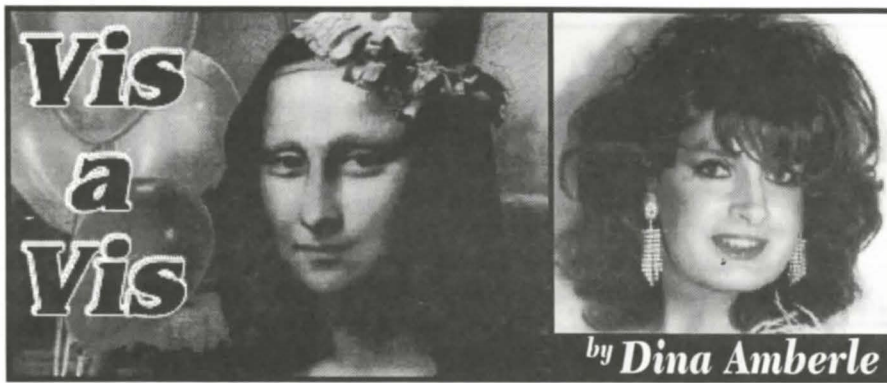

The much anticipated "Anthology" collection has been released memorializing the milestone 25th Anniversary and I'm sure it was in everyone's Christmas stocking. No, not the Beatles' CD. I'm talking about the Vis A Vis "Anthology" marking my 25 monthly columns since I began.

It's all in there from my first column, where I trashed Jane Kemper Bentley, to the ones in which I trashed Cassie Owens and Kiki Carmichael, to the most recent ones where I called Phaedra Kelly a horse's patoot. Yes, it's just chock full of that kind of community building spirit this column has become known for. Maybe I should turn over a new leaf for 1996 and be nice to everyone. What d'ya say? Nah, I didn't think so...

And The Survey Says...

Allison Marsh's column in the *Emerald City News* from Seattle, Washington, carried the results of a survey conducted by the Tempe, Arizona, Alpha Zeta chapter of Tri-Ess. The survey results were pretty interesting and represented the answers of 73% of the Zeta-girls' 47 members.

Some of the questions were rather mundane but some were very revelatory. So, without further ado, this very special episode of *Vis A Vis* takes a look at...

The Private Lives of Crossdressers.

To the question how often would they dress as women if they lived in an ideal universe, 36% of our Tempe Sun-goddesses answered, "all the time." When asked if they would take a hypothetical pill that would transform them

into women without surgery, a whopping 64% said, "Gimme that pill, girlfriend." On the converse, only 27% said they would take a hypothetical pill that would "cure" them of the desire to crossdress.

On more reality-based questions, the number of members who have had some electrolysis was 24%. That's close to one in four for you mathophobes. And 21%, or one in five, have used female hormones at some time. The survey upped the ante in a series of questions as follows... "fantasized about having sex reassignment surgery" got a 73% positive answer... "Seriously considered SRS" got a 21% positive response... "presently planning on SRS" was answered "yes" 9% of the time.

And before I analyze the answers, let's take a look at a few more survey questions. Asked how often they go out in public dressed as women, 61% said only once a month; 21% said once a week. Nobody admitted going out dressed daily, and 3% said they never went out in public crossdressed. To the question "how often do you wear some article of women's clothing while dressed as a man" a surprising 43% said "always." Also noteworthy was that 70% of respondents were married.

I always take survey results with a large grain of salt, but I find it remarkable that a Tri-Ess chapter has 64% of its membership who would like to magically transform themselves into women; 36% who would like to live full-time if circumstances were perfect; 21-24% who have experimented with either hormones or electrolysis; and a huge 73% who have even fantasized about TS surgery. That's a helluva lot of real and fantasized trans-

forming going on in an organization that is devoted to the ideal of heterosexual crossdressing without a taint of transsexualism in its ranks. A less diplomatic person than myself might even say this particular sorority of Tri-Ess girls are a bunch of secret transsexuals.

So are the members telling the truth in their survey answers? I think so, because they seem to be honest in the answers about the amount of time they really spend dressed as women. Only one in five go out publicly even once a week. Not a whole lot less (15%) admitted they only go out once a year. So they aren't inflating their level of real activity to match their fantasy transformations.

I wonder what the leadership of Tri-Ess would have to say about this survey. I can't imagine a similar survey culled from open membership groups would be any different insofar as the members might fantasize one thing while living quite a different thing. But as *Seinfeld* once quipped, "Not that there's anything wrong with that..."

Meet me In St. Louis

The Gazette is the newsletter of the **St. Louis Gender Foundation** and it's one of the better group newsletters in the country—and I've seen 'em all.

The St. Louis girls seem like a lively bunch and they have an interesting mix of group events to spice up their monthly routine. In September, they held a "Sexy Legs" contest and there is a group photo of the fifteen contestants. The three finalists all look pretty sexy indeed, although you can't actually see their prize winning gams.

Keeping up the level of fun, they had a "Undercoverwear" lingerie party and demonstration scheduled for November. For December they planned a "Big Hair" contest, the winner of which receives the "Wigstock" award.

A few of the support groups around the country—including the venerable Tiffany Club in Massachusetts—are having problems with membership retention and are battling a growing feeling of ennui among their core member base. Maybe if more leaders threw a little good-natured fun into the activities, as the St. Louis ladies do, some of

the boredom of the usual meeting routines would be dispelled. There are a lot of different ways to offer support and having a few laughs every now and then is a nice way to show that we're here for each other.

Lead, Follow, Or Get Out Of The Way

Vicki Thomas wrote a long article titled *The Four Signs of Dysfunctional Leadership* in the November issue of *Femme Forum* for the **Tau Chi** Chapter of Tri-Ess in Houston, Texas.

Vicki's article was written in anticipation of their sorority's board elections and her hope that voters will be able to recognize good leaders from poor leaders. She pointed out four areas that separate good leaders from bad. They are "Ego," "Integrity," "Responsibility," and "Change."

The ego-driven leader is likely to run the group in a manner that maximizes her own image and recognition factors. They are prone to go outside the group's bylaws because they think they are too big to be held back by someone else's rules. And they drive other good people away from leadership positions because they do not appreciate their assistants.

Integrity as a desired quality in leaders should go without saying, but Vicki points out because leaders lacking in integrity can be hard to recognize before it's too late. She says that while the ego-driven leader is often tripped up by her overt behavior, the integrity-poor leader will be operating "behind closed doors." She also says that it isn't only personal integrity that is important in leaders, but that they govern with integrity to the principles on which the group was founded.

In the area of Responsibility, Vicki warns against the power-seekers who crave the idea of leadership while abdicating the true responsibilities of the job. This is a real danger in crossdressing groups where the masculine ego can feel compelled to "be in charge" while the realities of leading a support organization can be difficult, i.e., integrating the job into a person's everyday schedule, perhaps being more open about her crossdressing.

Leaders must be open to "Change" when called for by circumstances, but careful not to abandon successful traditional policies purely for the sake of change. Personal growth is a form of change. Likewise, the evolution of a group is a form of change. Leaders must be responsive to personal and group growth for continued success without stagnation. Leaders of groups in trouble (and there are several distressed organizations around the country right now) need to analyze the true nature of the problem and make critical changes to address the problem. Otherwise, as Vicki points out, it is simply "rearranging the deck chairs on the Titanic."

The quality of leadership in transgender organizations is always a hot topic. A really poor leader—or group of leaders—can set back, or ruin a good organization. But even a great leader will only have limited success if the membership is apathetic. The success of our support groups depends on leadership, yes, but also on the amount of input and enthusiasm of the membership. As members elect new leaders, they should bear in mind that they, too, have a responsibility to help make the organization successful by supporting the programs, policies, and activities of those they elect.

Hooters, And The Men Who Grow Them

The Seahorse Magazine from New South Wales, Australia, carried an article called *Man Trouble*, originally published in the *Sydney Morning Herald* newspaper.

Of all the many forms of trouble men get into, this article dealt with men who grow female-like breasts. While this may seem like a blessing for certain transgenderists, most men who experience over-development of breast tissue find this embarrassing and troublesome.

Breast development (gynecomastia) in men is not uncommon and usually comes about at very early ages or in later years. It is usually associated with changes in hormone levels, e.g., in newborn males the breast are swollen as a result of higher than normal estrogen levels received from their mother's

womb. In later years, breast enlargement may indicate medical problems with the liver, thyroid, or kidneys. Certain medicines that either contain estrogen or other female hormones can account for some breast enlargement.

There are certain circumstance that are more interesting than the natural reasons for breast enlargement in males. Alcohol abuse damages the liver and can alter the male hormone balance causing breast swelling. Illegal use of anabolic steroids has accounted for breast development in some athletes. Amphetamines, heroin and marijuana also can affect hormone levels and cause breast enlargement. Some workers at a maker of oral contraceptives began noticing breast development due to absorption of estrogen through their skin. Likewise, vaginal creams have caused breast development in males who came in contact with it, presumably in large quantities.

They say that a little knowledge is a dangerous thing and this brief synopsis of male breast development should not be the basis for anyone to go out and experiment in self-hooter enhancement. If I see any of our subscribers taking deep breaths outside the birth control pill factory, or with fingers sticky from gobs of vaginal cream, while at the same time drinking cheap whiskey straight from the bottle and toking on a joint in hopes of being the next Dolly Parton, I'll be very disappointed. Not terribly surprised... but disappointed nonetheless.

Busted—In More Ways Than One

The Paradise Tales newsletter of the **Paradise Club** in Parma, Ohio, carried a news piece from Colorado Springs, where authorities charged Sean O'Neill, a FtM impersonator (she does not identify herself as a transsexual) with criminal deception and sexual assault after she had consensual sex with four teenage girls who believed she was a man, as she had presented herself. The young women in the case originally declined to cooper-

Gender Reflections

The Silence of the Lambs

No, this is not a review of the cannibalistic thriller but a paraphrase of a chapter title in Kate Bornstein's **Gender Outlaw**. (Thank you, R., who lent me this book because she knows how much I have to learn about the transgender situation.)

Kate writes of the silence of transgendered people who not only linger in the shadows of society at large, but do not even talk to one another. To those of you active in Renaissance, you may think I am preaching to the choir. After all, you attend meetings, go to parties, hold office in an organization dedicated to the support of the TG community and are not the silent ones. But there are those who dare not emerge even to the safety of such an inviting environment. Quoting Kate, "Simply saying 'Come out, come out, wherever you are,' is not going to bring the multitudes of transgendered

people out into the open. Before saying that coming out is an option (and I believe it's an inevitable step, one we're all going to have to take at some time), it's necessary to get transgendered people talking with one another. The first step in coming out in the world is to come out to our own kind."

What keeps transgendered people silently in the shadows? For one, fear of loss of acceptance by the dominant culture which expresses its disapproval of non-conformists by imposing numerous penalties upon those who stray from its strictures, such as discrimination on the job, in housing, custodial rights, and social stigmatization. For another, the inability to accept oneself as differing from others who have never questioned their gender identity. Language can be one's enemy as the transgender individual tries to conceptualize his/her difference and comes up with words like "freak," "deviant," or having a "condition of transgender-

ism," all of which have pejorative or pathologic connotations.

Another reason to keep shadowed and silent is the fear of not cutting it with other transgendered people. Even the most supportive communities have members who are elitist, exclusionary and doctrinaire with regard to whom they allow into their circle. No one emerges from the shadows a finely turned out image of their experienced gender. Contempt by their own adds insult to the injury inflicted by the larger society and contributes to continued isolation and silence.

This is hardly an inclusive list of conditions mitigating against TGs' emergence. But to enumerate more of the too well-known conditions operating is to restate that which has been discussed ad nauseam. Moving on to solutions is more challenging and less frequently addressed. Tune in next month for one person's view of a better world adorned and enriched by the presence of TVs, TSs, androgynes, drag queens, she-males, pre-ops, post-ops and no-ops.

ate until pressured by police, their parents, and the D.A.'s office.

As mentioned in the article, this case raises serious questions for any pre-operative or non-operative transgenderists, whether genetically male or

female. On the face of the charges, it appears that not disclosing one's true biological sex could leave that person open to sexual assault charges, even if the act was consensual. The article brings in the case of a MtFF transgendered person who was murdered by her date after her true biology was discovered (see the front page). If non-

disclosure of biology is considered criminal assault, this type of homicide could be "justified" as self defense.

We can only hope that someone in a position of authority in this case will take a step back and examine the ramifications of the hysteria that prompted the charges. May cooler heads prevail.

This has been an amazing year for me. I’m actually going to apologize for the second time. Last month I said that **NS Products** was on the verge of bankruptcy. They’re not according to a source close to the vendor. I regret the error. It seems I also led quite a few people to the conclusion that both *LadyLike #25* and the new *Transgender* (formerly *Tapstry*) from IFGE were on the street. Wrong again. *LadyLike* arrived mid-December and should be in subscribers’ hands by the time you read this. *Transgender* went to the printer in mid-December and due to the holidays may or may not be available at press time.

Renaissance begins its ninth year as one of the largest transgender organizations in the world. Last year saw unprecedented growth for the suburban Philadelphia-based organization with the addition of six new affiliates. Renaissance affiliated organizations now stretch from East Coast to West Coast and from the Gulf Coast to the Great Lakes. You don’t get more “national” than that. The “secret” of Renaissance’s success is empowering people to take responsibility not just for themselves, but for their sisters and their community. For some people, this concept is just too scary; treating people like adults and trusting them to do the proper thing. But this empowerment attitude is why Renaissance has grown from a single support group to a network of 17 organizations in 11 states. So, which group is going to be the first international affiliate? Hey, you up there in Canada. Anybody interested?

From First Lady Hilary Clinton: “It is no longer acceptable to discuss Women’s Rights as separate from Human Rights.” Likewise, we need to get people to understand that gay/lesbian/bi/transgender rights are inseparable from Human Rights as well.

One of the best things that has happened to the transgender community in the last two years is the increased accessibility of the Internet. I seriously doubt that the **Lobby Day** activity last October would have drawn 100 people if we had to rely on phone and mail communications. For all the gains the net has given us, we are in great danger of losing this wonderful resource. Both the House and Senate are considering proposals to effectively censor the Internet. Under these proposals, any “indecent” communication may be subject to a \$100,000 in fines and a jail term. The problem is who gets to define “indecent?” Right now, local community standards prevail in most pornography related cases. How do you define a “local” standard on a global network? Would the word *transvestite* be considered indecent in New York City? How about Tupelo, Mississippi, or Little Rock, Arkansas? How about the words *penis* or *vagina*? Will Congress lower the standard of Free Speech to the point where a library could be fined if they put James Joyce’s *Ulysses* or *Catcher In The Rye* on-line? I support protecting juveniles from harmful and inappropriate information, but I also feel that parents have the first responsibility to monitor what their children do in real space as well as in virtual space. The technophobes in Congress sponsoring these proposals (and they’re on both sides of the party fences) will use the bogeyman of the message-encrypting pedophile to push their measures through. These measures endanger not just Free Speech but digital commerce as well. Both the American Civil Liberties Union and the Electronic Freedom Foundation have vowed to take any net censorship law to court, but why wait until the damage is done? You can make a difference now. Call or write your Senators and Congressional Reps. Tell them you oppose any government censorship of the Internet and that this is an important 1996 election issue for you.

Dear Doctor Bill,

I go out shopping as a woman about once a month and I am concerned that I may be breaking some law by crossdressing in public. Of course, I don't want to stop but I would like to know how I could find out if there are state or local laws in the areas I frequent that might be used to arrest me. Thank you for any assistance you can render.

Looking Over Her Shoulder

Dear L.O.H.S.,

You have asked an excellent and important question! As far as I can find out, there are no specific laws that pertain to crossdressing in public. However, there are several things to take into consideration. First, there will probably be ordinances against using the toilets of the other gender. As you probably already know, one of the biggest problems that crossdressers have is finding a toilet that he/she can use. This tends to be the one major, common issue all transgendered persons face in a public setting. I have had clients who were arrested and prosecuted just because they used the toilet of the other gender. Yet to use a toilet of their biological gender would have created an uproar, too. This is a no-win situation.

Second, there may be local ordinances against crossdressing. It is helpful to get information about local ordinances before going into a community. This can be obtained from the local police department, a lawyer, or the town/city hall. I would think this would be more of an issue in a rural community or small town, rather than a large city or suburban area.

Third, while there may be no laws prohibiting crossdressing in a community, it is likely that there are no laws protecting the rights of transgendered persons either. This can even be more problematic because charges can be made or harassment can occur and you may not be protected by the law against such events. In my judgment, this is where the transgendered community needs to be politically active. I was so pleased to read this month the Presidential address for the Society for Psychological Study of Lesbian & Gay Issues (Div. 44 of the APA) when he said: "I would like to consider the subject of the bisexuals, transsexuals and transgendered among us. It is time for us to find ways to make these people visible among us. It is time for us not simply to find a place for them at the table but to protect their place at the

table as we do with ethnic minorities and the balance of genders."

Dear Dr. Bill,

Recently, I had the opportunity (I am a CD) to spend a weekend en femme. I checked into a hotel as dressing at home is a no-no. I wanted to check in en femme, but I began to think about what if they ask me for ID. I thought about saying I left it in my other purse but finally just checked in as a guy. I had a great weekend but I still wish I had been able to check in dressed. Is there any kind of ID I can get in my femme name so when I spend another weekend dressed I can be en femme the whole time?

Dear Alicia,

Pay cash for the room. There is no reason for the clerk to ask for any ID, unless the clerk is reading you and unsure of what to do. It is not appropriate to be asked for an ID if you are paying cash. Some hotels may ask for a security deposit in case of any damage.

Secondly, you could get a couple of credit cards in your female name and use them for ID. I believe that legally this is considered an "alias" and is not illegal as long as you pay your bill.

Finally, you could be very open and say you are a crossdresser. Act like you are proud of it and insulted by their narrow-mindedness. Usually this will put them off-guard and he/she will ask no more questions. You could offer to educate them about crossdressers, so they will understand when the next one comes in. American Boyz Join ACLU To Protect Net

The American Boyz, a gender education organization in the Mid-Atlantic region, has announced its intention to become a co-plaintiff with the ACLU and many other organizations opposing the restriction of First Amendment freedom of expression in cyberspace posed by the Decency Act currently before Congress. In the event that this bill becomes law, the ACLU and its co-plaintiffs will seek an injunction against it being enforced while the constitutionality of the law is examined.

Supporters of the Decency Act urge an even more draconian version of the current bill, essentially dumbing down online communication (phone, fax, email, newsgroups, etc.) to a level not offensive to a child. Gender variant people, who already have a difficult time obtaining information and support for their situation, rely heavily on electronic communication. Should the Decency Act become law, information regarding the medical, social, psychological, personal, educational, and

other needs of gender variant people could result in severe criminal and civil penalties. The American Boyz urges all fair minded people to support freedom of expression in cyberspace, and to let their Congressional Representatives know how they feel.

Dear Dina,

Hello dear, I just received Dec. 95 RN&V and would like to present a few comments to your *Let's Pretend*.

"If we are trying to express our feminine personality, why do we feel the need to bury it under wigs, makeup, and foundation garments," or in short, why do we pretend to be women? Well, I think the clothes are but a tool to bring out and to develop that feminine personality that lies within us. Can a person drive a nail without a hammer, can you drive a screw without a screwdriver? Of course the answer is yes, but how much easier is the job with the proper tool? Perhaps cross-dressing is the best tool we know to bring forth and develop the feminine persona with us.

But too, there is another reason for the "Pretend," and that is escape. Ask a crossdresser why they do it, and very commonly we hear, "It relaxes me." I think the truism in this is we are escaping the

real person we are and entering a world of our fantasy person. Perhaps the changing of the sex helps to make a further and more complete escape from our world of reality than in changing to, say, something like a Civil War soldier.

It would be wonderful to hear someone ask me to marry them instead of the other way around. The question is, if women treated men the way they are treated, would we continue to feel the need to crossdress?

And now, Dina dear, here is a question I pose to you, and to anyone else that may even remotely think they may have the answer; in almost all surveys of crossdressers it is found that only a minor percentage of us are gay. Anyone with any knowledge of the gay community will also notice that only a minor percentage of gays are also crossdressers. Look at any male seeking male ad, and it

Transgender Discrimination or Lookism?

We live in a world of "isms," sexism, ageism, racism, fascism and a few more so obscure they're not even worth mentioning. I'm going to add to the confusion with lookism.

I was first victimized by lookism as a little kid. I had to wear my "school clothes" and Mom's idea of what the well-dressed child wore to school and that of the other kids was slightly divergent. (There was the matter of that crewcut, too.) Since I didn't look like everybody, else I became a target. This kind of thing has gotten even worse in our modern world of designer fashions and "must have" accessories.

Sequined gowns were definitely **not** allowed. No women's clothes at all, come to think of it. I had to sneak those.

If Mom would have let me wear the clothes I wore at home to school I would have had an easier time fitting

in. I didn't fit in since I didn't look like everybody else.

Now, what's all of this about my dysfunctional childhood have to do with transgender issues? It's an unfortunate fact that the majority of the world will categorize you, judge you and treat you accordingly, based on how you look. Since this is the case, the transgendered person who looks the best in their chosen gender role is least likely to experience problems interacting with society. Even if people tumble to the fact that all is not as it seems, if you look fabulous, they will accept you more easily. *Well, sure she's a man, but he's so beautiful you can see why he does drag.*

What does this mean for the cross-dresser who wears a size 16 frock, stands six foot two in flats and has a very manly face? If she wants to go out and interact with the world at large she's got to be prepared for problems, problems based more on lookism than any other 'ism. *Look at that woman! She looks like a man in a dress. It is!* If she could play the passing game and fit in, she would be a lot more comfort-

able in public. She can't, and she shouldn't try. If, on the other hand, she becomes so paranoid that people will recognize her manly nature, she won't even notice if she does happen to have a good time. Lookism can only make you a victim if you subscribe to its belief system, which says there must be something wrong with anyone who looks different. You know there's nothing wrong with you. If you ask for respect most people will put aside their lookism and see you as a human being. If they can't do that, then they are the ones who have something wrong with them.



The Vinegar Tasters

I frequently hear and read about religion and transgenderism. These conversations are exclusively centered around how to interpret Christian teachings and tenets in such a way as to "justify" our right to be who we are. I find it odd that a relatively "new," predominantly Western, minority religion is used as the spectacles through which to view a universal and timeless phenomenon. Among the Five World Religions are Taoism, Confucianism, Buddhism, Christianity and Islam. There is value in all "good books" and in all "good teachings." Without a doubt, when we are dealing with such an issue as transgenderism, which is certainly not only a Western issue, we should expand our scope.

Let me talk to you about an ancient Chinese painting. Roughly translated, it is titled, "The Vinegar Tasters." In this painting, composed long ago, we see three men standing around a vat of vinegar. Each has dipped his finger into the vinegar and tasted of it. The expression on each man's face shows his individual reaction. The painting is intended to be allegorical and each of the three men represent one of the "Three Teachings" of China. The vinegar they are tasting represents the Essence of Life. The three men represented are: K'ung Fu-tse (Confucius), Buddha, and Lao-tse (author of the oldest book of Taoism). For the purposes of this story we shall call them Confucius, Buddha and Lao-tse.

The first man has a sour look on his face, the second wears a bitter expression, but the third man is smiling. Why the difference?

To Confucius, life seemed rather sour. He believed that the present was out of step with the past and that the world would be a much better place if there were strict rules. Confucius emphasized a strict order which ruled the affairs of all in his land. Anything that did not fit into the established order, was bad and not worthy.

To Buddha, the second figure in our painting, life on earth was bitter. This world, according to Buddha, was filled with attachments and desires that led to suffering. The world was seen as a setter of traps, a generator of illusions and a revolving wheel of endless pain. In order to find peace, Buddha maintained that it was necessary to transcend this world. The Buddhist sees the path to happiness constantly being interrupted by the bitterness of this world.

Now we come to the third man in our painting, Lao-tse. According to Lao-tse, the world was governed by the laws of nature, not by those of men. He maintained that the more man interfered with the natural balance of things, the more out of balance the world became. As things became unbalanced, trouble followed.

So why is Lao-tse smiling? We all know what vinegar tastes like. And, if the vat of vinegar represents the essence of life, should he not also have the bitter expression on his face? From the Taoist point of view, sourness and bitterness come from the interfering and unappreciative mind. Life itself, when understood and utilized for what it is, is sweet. That is the message of "The Vinegar Tasters."

How does all of this relate to transgendered behavior? Let us look at ourselves through the eyes of the three men in the painting and we shall see.

Confucius, set rigid standards of behavior. This is much the same as with Christianity. To step outside of these guidelines, is the determining factor for what is right and wrong, what is good and bad. Under this type of system the individual is not allowed to explore and "shame" as well as "guilt" are often the tools used to keep people in line. It is no secret that any type of transgendered behavior falls outside of these guidelines. As a result, many of our sisters feel tremendous guilt immediately following the joyous exploration of their alternate gender roles.

This leaves them with a sour taste in their mouths that is always associated with their feelings and need for self expression.

Through the Buddhist's eyes, while there exist no clear black-and-white definition or right and wrong, the key is desire. Buddha emphasized that desire causes suffering. He explained that when one strives to become or achieve something, failure results in sadness and misery. If, on the other hand, one had no desire, there would be no suffering. In GenderLand, we all have desires. We want to achieve a complete expression of the alternate gender within us. If we fail to reach the level of experience we wish for, we feel a "let down." According to Buddha, we would be happier if we never tried.

Now, let's look through the eyes of Lao-tse. To the Taoist, the femme nature within us is much like a reservoir of water waiting to be released. The water will flow eventually and cannot be stopped. In time, cracks or leaks will develop, and the water will flow. Trying to impede the natural tendency of the water to flow its course results in disaster. To Lao-tse, only by working within the laws that govern the flow of water will happiness be achieved.

To further illustrate, imagine washing your hands in the sink. If your hands work with the water, the task of cleansing you hands is accomplished quite well and without incident. Now, put your finger into the faucet to try to stop or alter the direction of the flow of water. What a mess! The water is going everywhere and you really can't stop it or control it. We all have had experience with trying to "stop" our transgendered behavior, and the result is calamity. Trying to "control" it with artificially imposed rules is often equally disastrous.

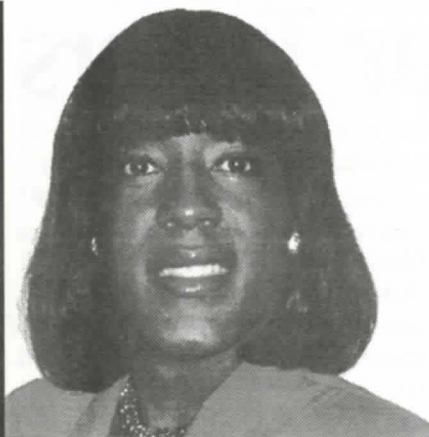
Lao-tse would encourage us to explore our gender roles. He would also caution us to neither impede nor force the emergence of our femme self. For the gender-gifted individual, the development of our femme selves should be natural and balanced, only in that way, will we find joy, and not bitterness.

of crossdressing as a whole, although not all queens would be as giving."

An excellent point Jess, but that takes us back to what Monica said about movies modifying reality. You know you're in for some fantasy when the trip from New York to Los Angeles takes the ladies through Bala Cynwyd. (Played a little too upscale by some town in New York state.) Drag is about illusion and fantasy, so what does it matter if things don't make that much sense when you examine them. If you look too closely at any great female impersonation you'll see those annoying little flaws. (Kind of like Swayze's giant size pores and the crow's feet I've been seeing in my mirror lately.) As long as the light is low and the plot keeps barreling along, the "girls" look great.

One of the flick's major departures from reality is in it's first premise: Noxema (Snipes) and Vida (Swayze) beat out the hottest talent in the New York drag scene to win the drag contest that sends them to L.A.. Not only do they win, but they tie for first place. Leslie Foster is another amateur crossdresser and member of Renaissance GPC. After seeing the show she said, "[John] Leguizamo was definitely the best of the three. I found myself identifying with the characters, and for three guys who probably never thought of playing this type of role before, (Leguizamo has portrayed drag characters and women

in his HBO specials and on his Fox-TV show, *House of Buggin'*) they were phenomenal."

Phenomenal, but not flawless. It takes the "willful suspension of disbelief" for us to believe last year's Queen of The Year was **Rachel Tensions** a statuesque beauty (played by the flawless RuPaul) and this year we get Wesley Snipe's with muscles bulging all over and Swayze wearing gloves almost the whole time to cover his large manly hands. (Come to think of it, I know crossdressers who do that.)

Don't think I'm some evil queen dishing the Hollywood actors. They did a great job and if Vida and Noxema had not been portrayed by major stars, the film would really be another *Priscilla*, a little art house movie that only the lucky few would see.

To *Wong Foo*, *Thanks For Everything*, *Julie Newmar* was a groundbreaking film. Its message is acceptance, from society and from within, and while other films in recent years have promoted tolerance of people who society views as "different," this is the first big-budget, gonna-be-seen-by-a-bunch-of-folks film that should make it a little easier for people to see that drag queens, crossdressers, transvestites and others with gender identity issues are not strange or perverted. They're just people. People with, as Noxema says, "Too much fashion sense for one gender."
