JOINT MEETING

On her way home from CHI's May meeting, Elaine MI-16-W found a potential location for the tentative CHI/Delta joint meeting this fall. Elaine writes: "I've found what looks like a perfect place for our joint meeting west of Holland, near Lake Michigan. This is about 175 miles from Detroit and about 160 miles from Chicago. The accommodations ideal for our purposes would be apartments, all in a single three-story building (one 'apartment per floor), located away from the main part of the motel. There is ample parking immediately adjacent. The building has a single entrance which opens into a stairwell leading to the three apartments. The living room of either the two bedroom or the three bedroom apartment would be of suitable size for the meeting room. However, for a large group, we might do well to rent the entire building. A program note gave credit to the Beaumont Society of England for much of their information and guidance. If this production should play in the States, it would be a real treat (and a treatment) for everyone to see it."

THE LAW (AGAIN)

In the September, 1977, issue of the Femme Mirror it was reported that "The Illinois Court of Appeals has ruled that Section 192-8 of the Chicago Public Morals Code is not unconstitutional, resulting in the conviction of two defendants charged with violating the ordinance by 'wearing the clothing of the opposite sex with intent to conceal his or her sex. " A survey of CHI Chapter members in February and March of this year indicated that this report was "news" to all of them, and a request was made in the March CHI Tribune that any of our readers who had any information on this item to forward details. No information was received, but Vikki IL-48-M recently sent in a clipping from her local (southern Illinois) newspaper: "A Chicago Ordinance banning men from dressing up as women was applied unconstitutionally against two transvestites who were arrested as they walked down a city street, the court ruled. The court reversed lower court convictions of Wallace Wilson and Kim Kimberley, who were fined \$100 for wearing women's clothing in a public place with intent to conceal their sex." We are glad to hear that this type of law has again been struck down, and hope that our legislators everywhere will "get the message" and eliminate this unjust and unconstitutional prohibition from the law.
