SALVATION ARMY FEARS LGBT PROTEST

Christmas Time Is When Salvation Army Takes In Lots of \$\$\$... (It's About the Money After All)

Gay rights activists are stuffing fake \$3 and \$5 bills into the Salvation Army's red kettles this holiday season, protesting its denial of health benefits to gay partners of its employees.

The protests have been scattered so far. But officials at the Salvation Army — which takes in more donations than any other charity in the country — worry that they will mushroom after the holidays, making the organization, like the Boy Scouts of America, a symbol in the divisive battle over gay rights.

"Just wait, it's going to come," said Salvation Army Commissioner Joe Noland, commander of the eastern territory and one of five members of the Army's national policymaking team.

Gay rights groups have hinted that a broad-based, national campaign may be unleashed when the timing is right. They have been reluctant to go on the offensive while bombs drop in Afghanistan and amid public desire for domestic unity in the aftermath of Sept. 11.

But "when all of this subsides, and it will, this issue with the Salvation Army will still be there and there will be a reaction," said David Smith, a spokesman for the Washington-based Human Rights Campaign, a leading gay rights group. "The same thing will happen to them that happened to the Boy Scouts."

The Boy Scouts ban gays, and in communities across the country, pressure has been put on the United Way, a major source of scout funding, to withhold money.

The current hullabaloo arises from the Salvation Army's decision — and later reversal of that decision — to permit its 13-state western territory to offer benefits to "legally domiciled adults," a broad term that could include gay partners of employees. At a time when the Bush administration is pushing government funding for faith-based groups, it illustrates the predicament some face in accepting money with stipulations that run contrary to religious beliefs.

"What can seem like a relatively insignificant decision — even a well-intentioned one — can five, 10 or 15 years down the line be one of historical significance. And this decision has that kind of importance," said retired Salvation Army national commander Robert Watson, referring to the insurance benefit.

"Is this homophobic? Some people might call it that. Those who judge us might use some of those terms.

"But if we change who we are to accommodate our culture or the pressures of those who would try to reshape us, we aren't who we say we are."

The Salvation Army, begun in London in 1865, says it is an evangelical Christian organization that serves the needy without discrimination.

But it also maintains that sex outside marriage is sinful. And in 1998, the Army gave up \$3.5 million from San Francisco rather than comply with a 1996 requirement that organizations doing business with the city provide the same benefits to same-sex domestic partners as to married couples.

Earlier this year, the charity turned to the White House for help. As reported by The Washington Post, the Bush administration agreed to issue a federal regulation preventing enforcement of ordinances such as San Francisco's. In exchange, the Salvation Army would help in passing the president's faith-based initiative, an effort to widen federal support for social programs run by religious organizations.

Stung by allegations of political deal-making and facing elimination of public funding in other western cities, leaders from the Salvation Army's western territory suggested a compromise: Offer employees the option of purchasing health care benefits for a "legally domiciled" member of the household, whether that person is a parent, a nephew or, in the few cities where such relationships are acknowledged, a gay domestic partner.

A scholarly paper written by Philip Needham, chief secretary for the western territory, proved persuasive.

"Just as we would not argue that our compassionate assistance to a gay couple in need of our services does not constitute support of their lifestyle, so I can hardly see how providing access to health benefits to an existing employee's domestic partner constitutes an endorsement of their relationship," Needham wrote.

In late October, the Salvation Army's national policymaking team, the Commissioners Conference, decided to give each regional territory autonomy in making benefits decisions.

The western territory announced it would extend benefits to legally domiciled adults. San Francisco officials applauded.

But there was outrage on another front: Psychologist and evangelical radio kingpin James Dobson, whose "Focus on the Family" is broadcast by more than 3,000 stations every weekday, urged listeners to protest the decision, "because it will lead to similar decisions and compromises" at other Christian institutions.

In an interview, Focus on the Family spokesman Paul Hetrick cited Harvard University and the YMCA as two organizations that began with a Christian mission but gradually lost their religious identity. He said the Salvation Army's insurance decision could put it on the same road.

The Army was flooded with complaints — from donors and from members of the Salvation Army denomination, which is kept financially separate from the charity. Watson, the former national commander and author of "The Most Effective Organization in the U.S.," was among the influential critics.

"Let's swallow hard," Noland, the eastern territory commander, recalled telling his fellow commissioners. "Let's take a deep breath and make this thing right."

In mid-November, the decision was rescinded. "We deeply regret the perception that the Commissioners Conference surrendered any biblical principles in making the original decision," the charity said in a statement.

While that satisfied the Army's evangelical constituency, others were outraged.

"They are violating their own anti-discrimination language in their own mission statement and they're doing it absolutely in response to pressure from conservative religious groups," said Roey Thorpe, executive director of Basic Rights Oregon, based in Portland.

Thorpe has encouraged stuffing red kettles with the fake bills, printed off the Internet. One bill says, "When the Salvation Army ends its policy of religious bigotry and discrimination against gay, lesbian, bisexual and transgendered people then, and only then, will this be a real dollar bill."

The Internet home page of the Washington-based Parents, Families and Friends of Lesbian and Gays also promotes the protests, which it says began with its Genesee County chapter near Flint, Mich.

Meanwhile, the American Family Association of Michigan has promised that for every fake bill found in a kettle, it will donate an equal amount to the Genesee County Salvation Army, up to \$1,000. "We've been averaging two, three or four fake bills per night," said Major Ralph Bukiewicz, the Salvation Army's Genesee County commander.

Colonel Tom Jones, a national spokesman for the Salvation Army, said fake bills also have turned up in Detroit, Chicago and Milwaukee. The impact has been insignificant considering that the Salvation Army collected \$1.4 billion in donations last year.

"There is something happening out there," Jones said of the scattered protests, "but it appears to be limited.

"At least at this point."

TGSF ExCom Meeting Minutes

The monthly meeting of TGSF's Executive Committee was held in San Francisco at the home of the President Aiyana Eveningstar, on Thursday, December 6, 2001 at 7:00 p.m. In attendance were President Aiyana Eveningstar, Vice President Rachael Janelle, acting Secretary Nicole Cook, Treasurer Stephanie Ann Blythe, Education Chair Ally Grillo and Outreach Chair Kalani Makanani. Social Co-Chair Tianna DeVil was absent.

Debbie Cook was a guest.

The meeting was called to order at 7:50pm.

Minutes:

The minutes were inadvertently sent to print before the ExCom could read them, so the minutes were not approved at this time.

There was, however, an amendment to last month's minutes by the Education Chair Ally Grillo. The amendment states, "The Education Chair wishes to state that there has been no cutback of seminars, despite contrary indications contained within the President's report at the November 8th ExCom meeting."

President's Report

Aiyana has been working with the Franchise Tax Board regarding the missing tax filing. She has submitted a letter to them and is currently waiting for a reply.

Aiyana has found a paper in Janis' box of Secretary stuff that needs to be sent in to the county tax board that confirms we are a non-profit organization. That has been taken care of.

Finding new insurance coverage is another matter Aiyana has been working on. She mentions that we could save anywhere from \$500-\$800. She is waiting for final proposals now.

Vice President's Report

Rachael mentioned that we needed to order a sash still for the Cotillion. Nicole has confirmed that we will order that as soon as we can.

The Cotillion page on the website also needs some revisions to include the pre-show, out-of-towner event and post- Cotillion brunch information. Also a mention of where to send money for tickets was a request to be added as well.

Rachael handed out the latest Projected Income sheet, expense sheet as well as the ticket sales so far. We are still on budget. To date, we have brought in about \$3,000 in ticket sales. We have about \$500 in ads sold for the program as well. The awards have come back as well as the crown and were given to Aiyana to hold.

Ally was asked if she could woman the table inside the Design Center to answer questions regarding the club, handing out pamphlets, etc. It would be nice to have the table open before the show and during intermission. She happily volunteered.

The next Cotillion meeting is Monday, December 17^{th} at 7:00pm.

Momma Reinhardt, one of the judges of the Cotillion, asked if TGSF would be interested in running an ad at her event in February. It is the 36^{th} Annual Motorcycle Awards Event held in San Francisco. The cheapest ad would be a \$50 half page. The ExCom agreed it would be a good idea to participate as long as we have the funds in January.

Acting Secretary's Report

We have a current membership of 189. We still don't have addresses for 12 members. We have had so far 13 new members sign up using the online service and this is a good sign. A couple of members have paid via PayPal, which Debbie has sent Stephanie Ann a message about so it could be recorded in the treasurer's journal.

Nicole has spoken to the people at the Car LLC program in which we donated 2 of our cars and she is not very happy with the results. Evidently, the cars didn't sell for hardly anything. Nicole sent a message back to them to let them know of our disappointment for selling a running car for less than \$100. This worked great for Jaime Fenton's car, but just not for ours. Some money will come, but as a result of the low amount, Nicole has stated that she will pay membership dues outside of that. Nicole requested a check in the amount of \$150.00 instead of the \$198.41 that was spent out of pocket on the awards. Rachael suggests that the full amount be reimbursed to Nicole and that the membership be given to her for this year for her help with the Secretary position. Aiyana mentions this is ok with her as well.

Two sets of address labels as well as return labels will be printed this time and sent to Aiyana since January will be a busy time for many of us.

Treasurer's Report

The bank account is currently at \$914.24 once all of the bills have been paid and the Cotillion payment goes out. Stephanie Ann will email a list of those members who have paid to Nicole so she can match it up to the membership database.

Education Committee Report

Again, the next educational seminar will be on January 12th at 2pm at the Women's Center. It will be a seminar on plastic surgery with Dr. Brink. He would like to presents slides however, we need an overhead projector or device he can hook to his computer. Aiyana says she will check with Lichen to see if we can use his.

Ally mentioned her disappointment of what happened during the last ExCom meeting with the vote to supposedly cut back on education activities. She was very upset that this had taken place since she was not at the last meeting. Ally wondered if it is a budget problem or a problem getting the personnel to staff such events. Aiyana mentioned it is a staffing thing. With not all of the chairs being filled on the ExCom, everyone is being pushed to the limit. Ally mentions that not a lot of people are needed to put on the seminars and that Stephanie Ann has been co-managing the events with her. Nicole mentions that the vote was for a minimum number of events. The issue was set globally. It basically is a message to the members that if we cannot get volunteers to help, the amount of events are likely to decrease. That doesn't necessarily have to be followed. The number of events the education position would like to hold can be as many as can be handled. Aiyana supports Nicole's statement. As a result of this discussion, an amendment to the minutes has been posted above under the Minutes section of the newsletter.

Sex Talk

SPEAKING OF CROSS-DRESSING

Sex can be a drag. On the other hand, drag — men dressing in women's clothes — can be very sexy indeed.

Guys who cross-dress come in many varieties. There are male-to-female transsexuals who, though woman-identified, still have pretransition bodies beneath their frocks. Tranny cross-dressing is primarily about gender identification, not sexuality — some male-to-females are gay, some bi, some kinky and others as thoroughly vanilla as your grandma.

Things get a lot more sexy, though, where transvestites are concerned. Classically defined, transvestites are folks who get off wearing the clothing of the opposite sex; we're not talking about guys who go out on Halloween wearing bad wigs and big fake boobs. It's generally agreed that the vast majority of male transvestites aren't gay-identified at all. More likely we're talking about somebody like nice Mr. Macy down the street, who gets a boner putting on wifey's frillies while she's at the bridge club. And many of the men who get off on other guys in full drag think of themselves as straight, too; just ask any transvestite hooker about her johns.

Still, it's no surprise that plenty of the guys turned on by women's clothes are in fact gay or bi. Queer men are in a great position to cross those "boys wear blue" boundaries. Many more or less effeminate men find that drag lets them play with self-image in rewarding ways, exploring the blurrable frontiers of gender while feeling sexy as hell.

But drag isn't just for the less-than-butch. One beefy guy, the kind of gay man who could pass for a motorcycle mechanic even if that wasn't just what he is, confesses, "I like wearing women's panties, the silky kind. Sure, men's underwear is available in all sorts of sexy varieties, but there's just something about slipping on panties made for a woman that gets me off. That's it, though; other than that, no women's clothes." And even men in the leather community, with its supermasculine image, have been known to trade their boots for high heels. In "leather and lace" events, leathermen compete in cowhide, then transform themselves into fashion models that could give Miss America a run for her rhinestones.

Drag can also spice up a sex scene. Messing around with gender can be big, hard fun in which women's fashions are near-indispensable props. It need not be anything elaborate, though. One guy showed up at an unsuspecting buddy's house carrying a paper bag, popping into the bathroom and emerging shortly thereafter in nothing but a velvet miniskirt and elbow-length gloves. "It was a total shock," says the host, "but I just hiked up his skirt and got busy."

Cross-dressing scenes can be playful or seductive. They can also be just plain nasty. "One guy I know, a butch little hairy fire-plug of a man," says a kinky queer, "had me dress him up in Frederick's-of-Hollywood-style bra, panties and stockings and then treat him like a slut. He loved it. Actually, we both did."

These "forced feminization" scenes can be like playing with fire; after all, homophobes think that gay men are sick for "wanting to be like women." And misogyny rears its ugly head sometimes, too. But, like any other kink, if approached consciously and consensually, cross-dressing can be fancy, fabulous fun. "I'm pretty clear," says the motorcycle mechanic, "that I'm not a woman, and don't want to be a woman. I just like wearing panties. I'm cool with that, and so are the guys I have sex with." Ken in public, but Barbie in the bedroom? Sure. Why not?

"My FATHER WANTED TO BE A WOMAN"

Laurie Cicotello was a teen when she discovered her dad was a transsexual. Here, she describes how she dealt with his dramatic transformation. As told to Gina Zucker Until my early teens, I was part of what seemed like a regular suburban family: We had enough money and a nice house in Colorado, and my parents were happily married . . . or so I thought. Life as I knew it had always felt ordinary, but when I was 14, something happened that brought my illusion of normalcy to an abrupt end.

A Shocking Discovery

As an only child, I was definitely Daddy's little girl. I felt more comfortable with my dad than with my mom, and I never found it strange that he had an effeminate side. Both of his ears were pierced and he had longish hair, but that was the style in the 1980s, so my friends and I just thought he was cooler than most fathers.

I was a typical adolescent with raging hormones and a rebellious attitude. Late in the summer of 1985, just before I entered high school, I began stealing money from my parents' room to buy junk food. One day, while rummaging through my dad's drawers looking for cash, I discovered weird porn magazines that depicted women with penises. I didn't understand what they were, and I was so caught up in my own life that I chose not to think about it. But about a month later, I found photographs of my dad wearing women's clothing, as well as his journal, which I couldn't resist reading. While I don't remember everything he wrote, one sentence sticks out in my mind: "I'll commit suicide if Laurie ever finds out the truth." "The truth about what?" I wondered.

I was devastated that my father, to whom I'd always felt so close, had apparently kept a major secret from me. Confused and upset, I confided in my best friend from school - a guy named MacGregor - about what I'd found in my dad's dresser drawer. Knowing I wasn't very close to my mom, MacGregor convinced me to talk to my paternal grandmother, thinking she might be able to shed some light on the situation. About a week later, I went to her house. When I told her what I had seen, she began to cry. She said, "Daniel [my dad] has been dressing in girls' clothes since he was 4." Grandma had always kept it a secret from the family; she told me how he'd played with dolls and worn his sister's hand-medowns until his father took the dolls away and told him to be a man.

I decided I had to confront my dad. A few days later, he, Grandma, and I went to play miniature golf. As the three of us drove to the course, my grandma said, "Daniel, Laurie knows about what's going on with you." I started to cry in the backseat, and my dad and grandma cried as well. We didn't say much more at that point; we just went and played a crappy game of miniature golf. Eventually, my dad and I talked, and the truth began to surface. He told me that he felt he should be a woman but he was born with the wrong equipment. He said Mom had known about this from early on: She'd walked in on him while he was wearing a dress six months after they were married. She loved him though, so she stayed with him. He'd been transitioning to a more womanly appearance over many years - growing his hair and nails,

WHEN BAD DREAMS HAPPEN TO GOOD PEOPLE

The other night I dreamt that a hand was clutching the back of my neck. I didn't know it was a dream of course, or else I would not have tried to cry out for help; tried, but the words wouldn't come. The hand held me fast, paralyzing me with fear. I opened my mouth and feebly pushed out a groan, then a quite audible "Help!" which woke me up to find my arm bent behind my head and my own hand firmly gripping the back of my neck. I felt relieved yet foolish, like a dog that realizes it's been chasing its own tail; or a James Thurber character: "Aunt Shirley, whose constant cries in the night awakened half the neighborhood, along with Uncle Earl, a light sleeper himself, who resisted the urge to replace Aunt Shirley's errant hand at her neck with two of his own..."

How could this have happened? Once, taking a personality questionnaire, I remember answering "What position to you sleep in?" with "B. On my side, legs slightly bent, arm under my pillow." None of the choices came even close to "On my back, with my hand clutching the base of my neck," nor would I have checked such an answer.

I often have violent dreams even though I am not a violent person. Whether I am a good person I am not in position to say. I like to think that I am. I have been known to pet dogs. When approached by beggars I sometimes bestow a quite generous smile. I vote Democratic. If I'm not a good person, I'm not a horrible one, so why should I have bad dreams? And why should I attack myself? Am I trying to kill myself for the insurance?

What we must remember—or, I must remember (you don't have to remember anything)—is that when discussing dreams we are delving into the realm of the unconscious. The first thing to know about the unconscious is that it has no conscience, only desires. It isn't as nice and smart as the rest of you and it doesn't care a fig about you, only its own desire for money, sex and power. And you, you are a mere tool, or impediment. It doesn't stop to think that to get away with murder, one must be able to get away; that is, physically flee the murder scene. How can the unconscious be so diabolical and yet so stupid?

OutFront Minnesota Decries State Supreme Court's Transgender "Bathroom Decision" As Contradicting Common Sense

(Minneapolis) OutFront Minnesota, the state's leading advocacy agency serving the gay, lesbian, bisexual, and transgender communities, announced its regret over today's decision by the Minnesota Supreme Court denying the right of transgender citizens to appropriate restroom access. "To some, the issue of restroom access may seem trivial," said Ann DeGroot, Executive Director of OutFront Minnesota, "but those restrooms symbolize the traditional male-female categories which, as the Legislature realized many years ago, not all people neatly fit into any more. Further, the issue implicitly raises the question of who is entitled to define a person's gender identity: individuals themselves, or their employers?"

The case, Goins v. West Group, involved a growing work-place controversy: which restroom does a transgender person use? Julienne Goins, a former West Group employee, had transitioned from male to female even before beginning work at West, yet had been denied access to the women's restroom upon transfer to its Minnesota facility. Goins argued that restroom access should be based on one's consistently-projected gender identity, not on an employer's speculation as to its employee's anatomy. "Common sense says we interpret other people's gender based on their clothing, grooming, name, and so on, without ever knowing what their genitals look like," observed DeGroot. OutFront Minnesota and the Minnesota Lavender Bar Association submitted a friend-of-

the-court brief arguing that the legislative history of the Minnesot, Human Rights Act's "sexual orientation" provisions supported this interpretation.

"We're very disappointed the Court held that the law permits employers to ignore a person's everyday appearance, and focuses instead on areas of the body employers have no business demanding to see," said Phil Duran, OutFront Minnesota's Legal Program Coordinator and author of its brief. "This decision makes a mockery of the Human Rights Act by effectively mandating that transgender employees describe their genitals in order simply to go to the bathroom. This is the same sexual harassment this very Act prohibits." Duran predicted that transgender Minnesotans may now face demands to describe their genitals in order to access restrooms in public accommodations, such as restaurants, and in other circumstances.

The case had attracted national attention, and was the first in which the Minnesota Supreme Court had interpreted the transgender-related language of the Human Rights. Act. That language has served as the basis for similar civil rights protections in other states since the Legislature approved it in 1993.

Jackonsville Community Activist Murdered In Front Yard

Loss of Terrianne Summers Leaves Community Shocked and Saddened

Equality Florida joins family and friends in mourning the loss of transgender activist Terrianne Summers who was gunned down outside her home Wednesday night.

While the Jacksonville Sheriffs Office has no suspects at this time, the circumstances surrounding the murder indicate the attack may have been a hate-crime. Equality Florida recognizes that transgender people are statistically the most targeted group for hate violence in America today, and we call on law enforcement agencies to fully investigate the possibility that this was a bias motivated attack.

The murder comes in the shadow of November 28th, the third annual National Day of Remembrance for transgender people killed in hate crimes. According to statistics collected by the education organization Gender Education and Advocacy, hate crimes have resulted in the murder of nine transgender people in Florida, ranking our state as sixth most dangerous in the country. Unfortunately these grim statistics represent only a fraction of the violence transgender people experience because law enforcement agencies often undercount or incorrectly classify hate crimes against transgender people due to lack of education and awareness of gender issues.

According to the First National Study of Transgender Violence performed by GenderPAC, 60% of transgender people nationwide have been the victims of violent assault with nearly half requiring medical care for their injuries.

Terrianne was a human rights activist who worked closely with local and state human rights organizations and who helped to organize and empower the transgender community in the Jackson-ville area. Her sudden and violent death is a great loss for her family and friends as well as for the transgender community long ravaged by hate-based violence.

"Terrianne was always quick with a smile and eager to help others," said Jessica Archer, fellow transgender activist and friend who works for Equality Florida. "She showed tremendous courage to be out and active in a part of the state where transgender people are highly misunderstood and are generally afraid of being visible."

Terrianne Summers is survived by a spouse and two children.

getting electrolysis and a pair of women's eyeglasses. It was such a slow process that I had never put it together. Some transgendered people just dress differently and leave it at that, while others have sex-change operations. But in any case, they want to present themselves publicly as the sex they feel they really are inside. Suddenly, it all made sense. I remembered how my dad used to go on business trips with two suitcases; now I realized that one was for his male clothes, the other for his female outfits. My dad also went out a lot at night, and while he was getting ready, my mother often took me into my bedroom, saying "I have to talk to you about something" so that I wouldn't see him leave dressed in drag.

Keeping the Silence

One of the hardest things for me to process was the deceptive deal my parents had made. Dad explained that my mother had given him a choice years ago - keep his secret under wraps or she'd divorce him. Most important, she threatened to leave him if he ever let me find out he was a transsexual. My mother is conservative and shy - letting the outside world in on this would go against her moral makeup. So, fearful of breaking up my parents' marriage, I didn't talk to my mom about any of this. But my father, on the other hand, was relieved not to have to hide it from me anymore. At this point, he had started taking female hormones. And to help me adjust to his transformation, he decided to send me to his therapist who specialized in transgender issues. My dad also said that he wanted to be called "she" instead of "he" from now on and that his name would be Dainna. "You can call me Aunt Dainna if you'd like," he said. I suppose he thought we could keep this between us without my mom finding out, as unrealistic as that now

I didn't know how to feel, except numb. I went to the therapist, and she told me Dainna was going through "puberty" as she became a woman. This meant she wanted to do teenage things like go out a lot and share my clothes and makeup. I needed to accept this, the shrink told me, adding, "Dainna's emerging puberty is as important, if not more so, than your own." Obviously, this confused me and pissed me off. I now know that in families in which one parent is coming out of the closet or is transgendered, life often revolves around them while the rest of the family members' problems are neglected. As a result, I went into a deep depression and gained 100 pounds. I stopped wearing makeup because I had no intention of sharing it with my father. I felt alone and unattractive, and my self-esteem was too low to do anything about it. I certainly didn't feel like I could turn to my parents for help.

As Dainna's physical transition became more and more obvious, my mom continued to pretend that nothing had changed. Her husband was her closest friend, and I think she just couldn't stomach the idea of leaving him. At first, our neighbors just thought a woman had come to live with us. But inevitably, they realized what was going on. Kids began to make fun of me when I walked home from school. One boy would yell things like "There goes the fat chick with a faggot for a father," and the other kids would laugh. The next couple of years were rough. As my dad gradually went public, wearing female clothes during the day and living life as a woman, I started hooking up with guys who were often physically and emotionally abusive, another by-product of my nonexistent self-esteem. I also had to deal with plenty of mortifying incidents, such as the time our car broke down a block from our house

and Dainna had to get out and ask for water for the engine from some neighbors. He was wearing a bright floral-print romper, and I was trying to shove myself down in the backseat so no one would see me. For a teenager, when your parents already embarrass you, this was over the top.

Acceptance At Last

It was a relief when, in August 1990, I left home for a small Catholic college in Hastings, Nebraska. I told no one about my dad, but very soon after I arrived, I realized I was sick of feeling helpless and ashamed. A few months into my freshman year, I made a decision to come out of the closet with the family secret. I began to tell my friends about Dainna, spoke up about her in class, and talked to anyone and everyone about transgender issues. Although at first I was teased by a lot of people, I also found that opening up about my life made people feel comfortable telling me their own secrets and troubles. For the first time in a while, I began to feel I had something to offer. One day when I was walking through the quad, I overheard a guy say to his buddy, "That's the girl whose father is a woman." The other guy just looked at him and said "Yeah? So?" It felt really good to be finally accepted.

After I graduated, I moved to Denver, near my hometown. and tried my hand at journalism and then worked as a clerk for the city government. Ultimately, I began to teach English, and I'm now a high school teacher in Hawaii. My parents remain married to this day. They don't have a sexual relationship, but they continue to be best friends, and however strange it might seem, this arrangement works for them. My mother has had to reconcile herself to the fact that her husband's secret is out, but she'll always be private about it, and that's okay. Because of them, I've learned to accept people's differences, and I'm able to see the shades of gray in any situation. I still say "Mom and Dad" half the time and get Dainna's pronouns screwed up. But I feel closer than ever to both of them. As for me, I'm now 30 and single. For the first time, I feel that I'm ready for a real, intimate connection with a boyfriend. I'm looking forward to having a healthy relationship with someone who really loves me and can accept my unique family.

TRANSGENDER WIDOW'S CLAIM

The Kansas Supreme Court heard arguments Tuesday in the case of a transgender woman who is fighting for recognition of her marriage in an estate dispute.

The woman, J'Noel Gardiner, married 85-year-old Marshall Gardiner in late 1998, when she herself was 40. Marshall Gardiner died without a will less than a year after the marriage, and J'Noel found herself in a probate dispute with Gardiner's son Joe over the disposition of some \$2.5 million.

Initially, Joe Gardiner asked the probate court to declare him executor of his father's estate. But after discovering that his step-mother was born a man, he asked a district court to declare the marriage void, based on her sex at birth and the state ban on same-sex marriage.

Although the district court ruled that J'Noel was legally male and that the marriage was not binding on the estate, a state appellate court reversed that decision in May of last year. Gender, ruled the three-judge panel, is based on numerous factors and cannot be legally fixed at birth. The Supreme Court will now resolve the question for the state of Kansas.

In 1999, a Texas appellate court ruled that birth sex determines legal sex for the purposes of marriage. The ruling, from the San Antonio-based 4th Court of Appeals, meant that Christie Lee Littleton could not sue for the wrongful death of her husband of seven years — despite the fact that Littleton changed her sex some two decades earlier.

If J'Noel Gardiner loses her case, she could have recourse to the U.S. Supreme Court. When Littleton appealed to the high court, three justices voted to hear the case, just one vote short of the necessary total.
